Welcome and thank you for participating in this year’s Farmers Feed the Hungry Christmas Parade. We are looking forward to a large crowd.

WHERE

The Christmas Village is located at the northwest corner of the Lisbon traffic circle at the intersection of Route 94 (Woodbine Road) and Route 144 (Frederick Road).

Bring your own tables & chairs, tents (weights to anchor tents in case of wind) and extension cords. There are limited electrical connections.

WHEN

The Christmas Village is open from 10:00 am till 2:00 pm. The Village will be open for setup at 8:00 am and all vendors MUST be setup by 9:45 am. There will be considerable traffic and road closures in the area so please be in place early.

The Christmas Village is a hive of activity prior to the parade and even more activity after the parade.

REGISTRATION

Registration fee is \$40.00 prior to November 15, 2017 and \$50.00 afterwards. Registration closes December 1, 2017. Non-profit spaces are free. Checks should be made payable to Howard County Farm Bureau. Vendor spaces will be assigned on a “first come first served” basis so sign up early to get the choice spaces. The Christmas Village is a family friendly venue and the Vendor Committee reserves the right to decline participation. Food Vendors, Food Banks and Musical Entertainment will have assigned spaces. Registration fee is non-refundable.

COORDINATION

A parade representative will be on site to assist you finding your designated space, direct you to vendor parking and address any concerns. If you arrive and don’t see a Vendor Representative call Barb 410-489-9757 or Lynda 301-606-0115. Setup will open at 8:00 am.
